

Datum conversions in the area are ADOT + 8.30' = NGVD 1929 and NGVD 1929 + 2.90' = NAVD 1988 (ADOT + 11.20' = NAVD 1988). The recorded plat has a minimum finished floor elevation of 4998.00 on the ADOT datum (5009.20 on the NAVD 1988 datum).
