The BFE listed in B9 is determined from the effective FIS Profile. The recorded final plat was also considered; it states a MFFE of 5030.50 (ADOT Datum). Conversions in the area are ADOT Datum + 8.30' = NGVD 1929, and NGVD 1929 + 2.95' = NAVD 1988. Converted MFFE per the recorded final plat is 5030.50 + 11.25' = 5041.75 (NAVD 1988). The BFE from the effective FIS Profile (5043.7, NAVD 1988) is used because it is higher. The elevation listed in C2.e is the A/C unit located on the right (southwest) side.
