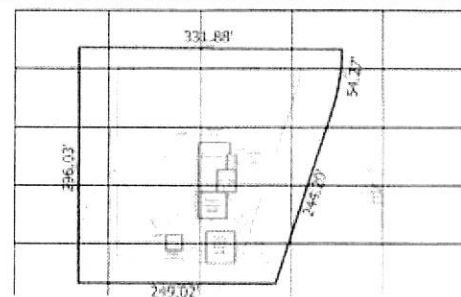


Plot Plan Sketch and Affidavit

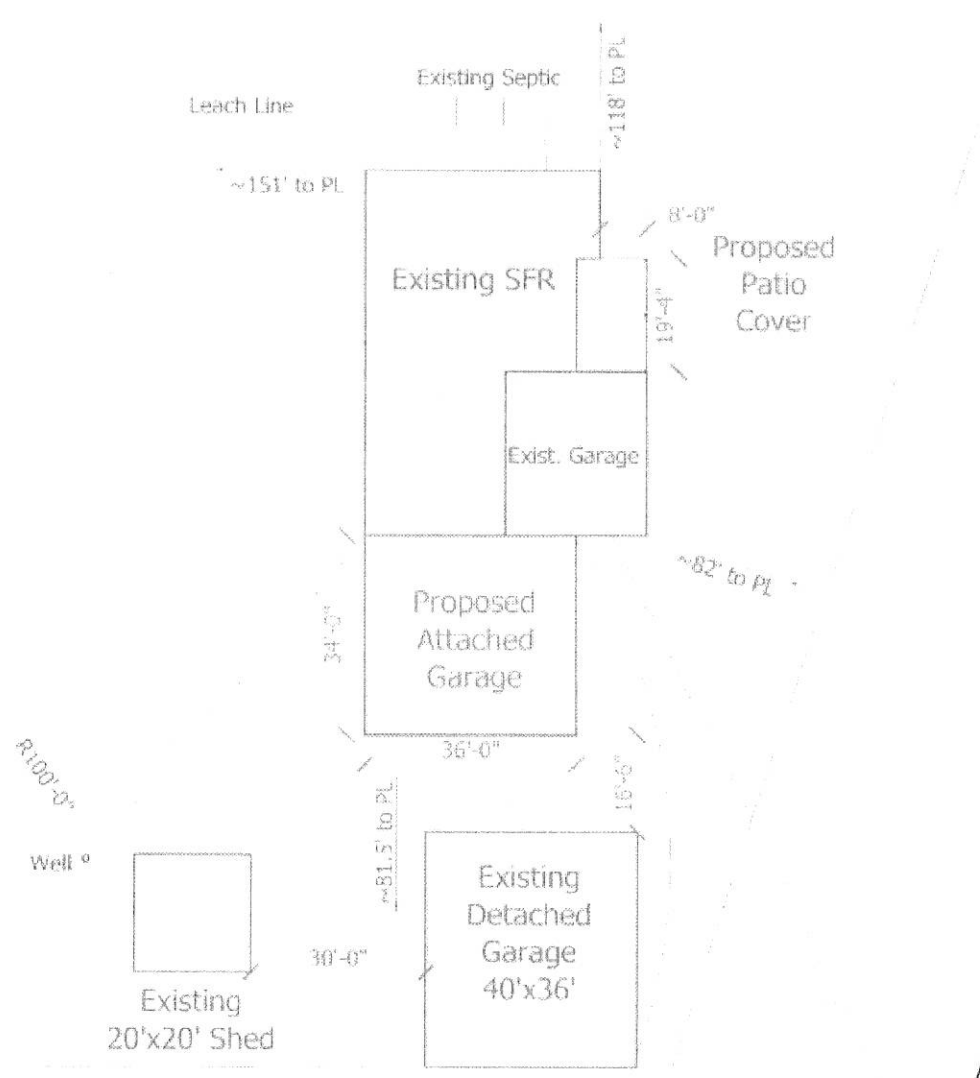
