The lowest machinery is on the southwest corner of the structure and is a water pump that is in a box. The pump is .20 below lid and H2O lines 1.50' below lid. This surveyor feels that the digram (A.7) should be an 8 or 9, however a 6 was chosen at the direction of ADWR as the building is a mobile and it is their understanding that a mobile will be a 5 or 6. The lowest horizontal member (C.2.c) is 4856.59'
