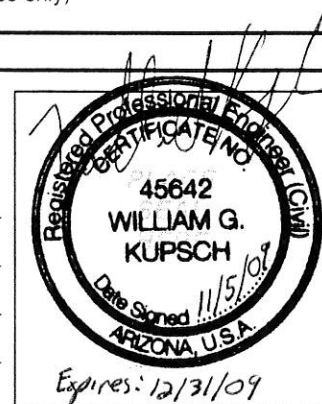

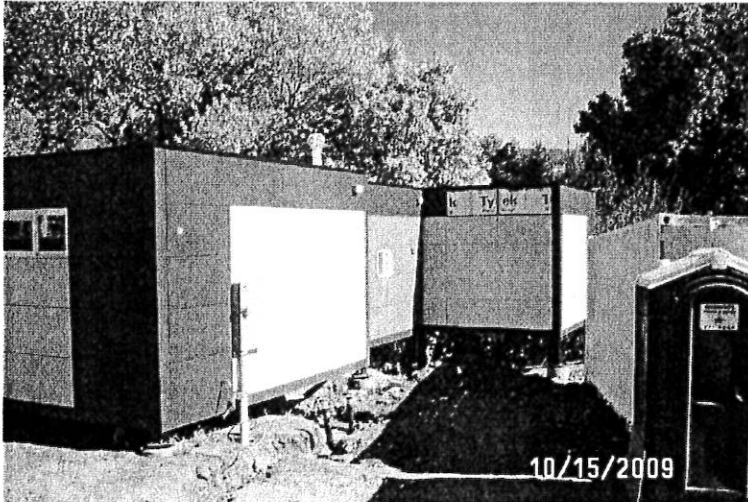

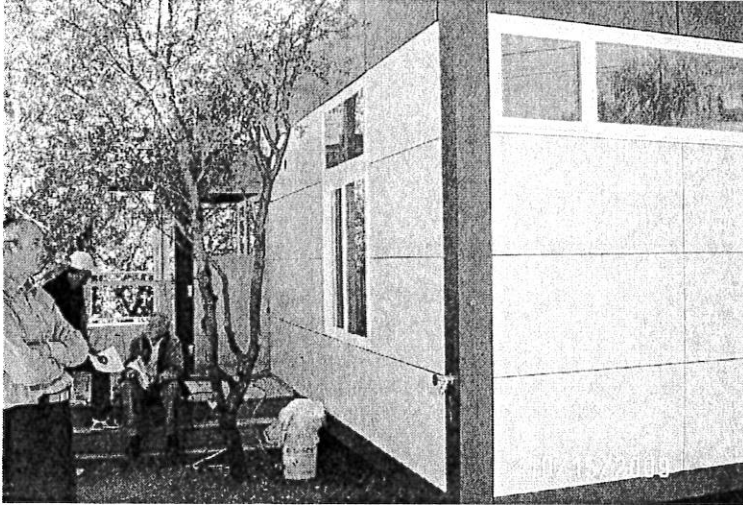
Facing South- Front of Structure



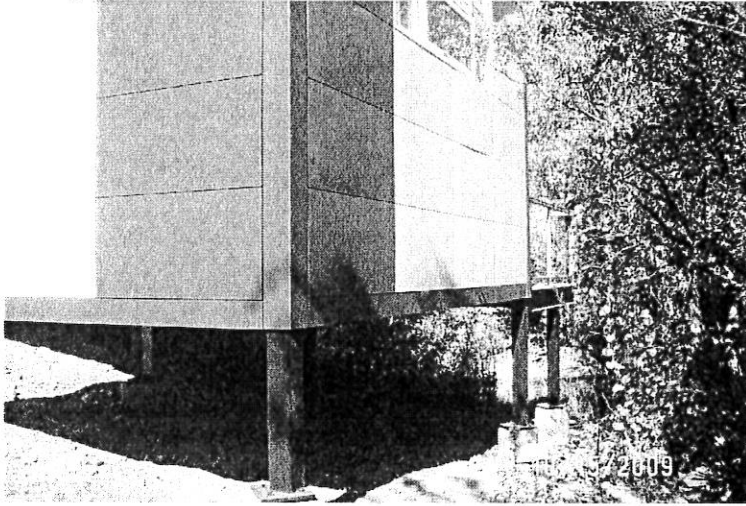
Facing South Easterly- Front and Side of Structure
