This EC is for the Residential Addition only. Lat/long in A5 was obtained from Google Earth. B8: Effective FEMA FIRM shows the structure is in Zone A. B9: The BFE is obtained from the hydraulic model by Lyon Engineering dated 12/9/2022. Since the addition will be structurally connected to the existing house, the BFE was taken at the most upstream house edge. Since a detailed hydraulic model is used, Section C is completed instead of Section E. C2.a is assumed (no access). The elevation listed in C2.e is the A/C unit located on the back (west) side.
