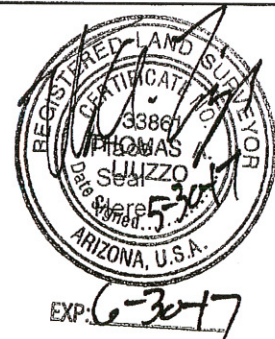

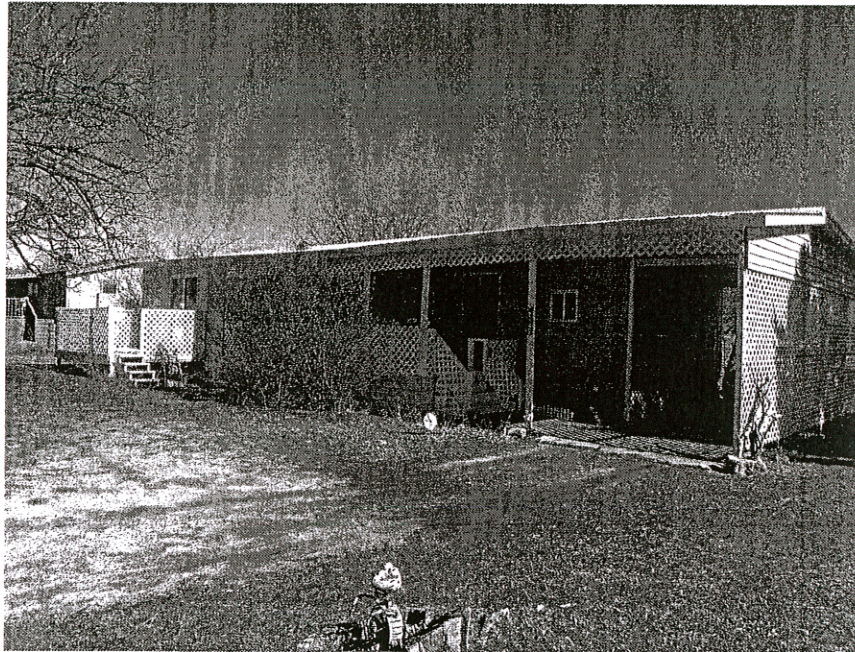

Photo One Caption Front View; West Face

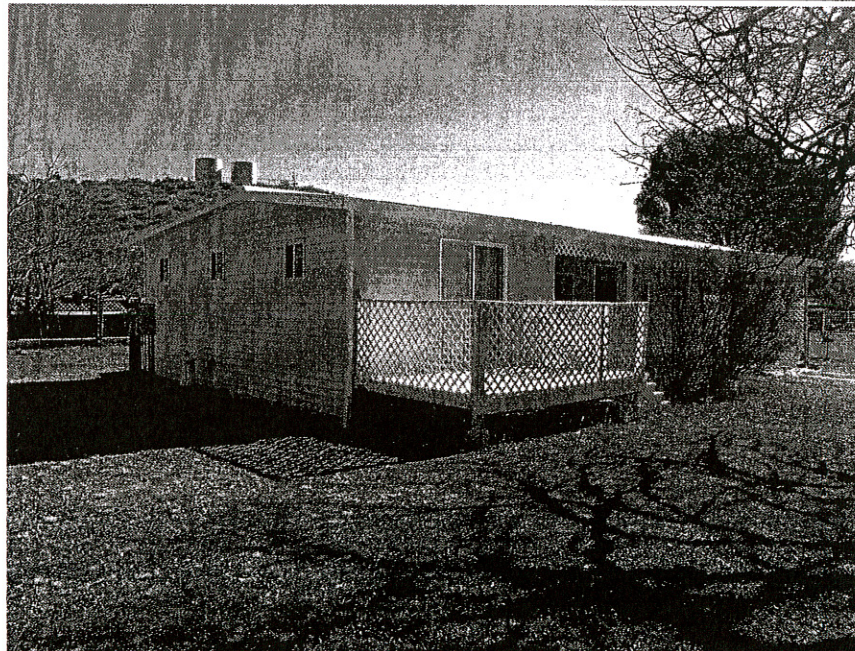
