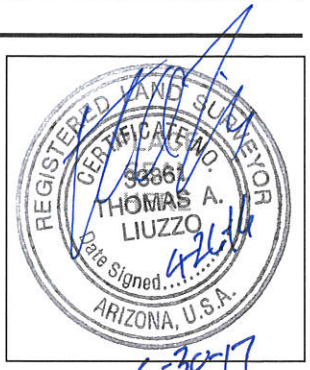

The Arizona room is the next lower floor after this. Only the north part of the house has been included in the crawlspace square footage. Lag at deck or stairs is at deck.

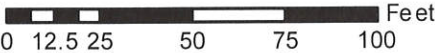
