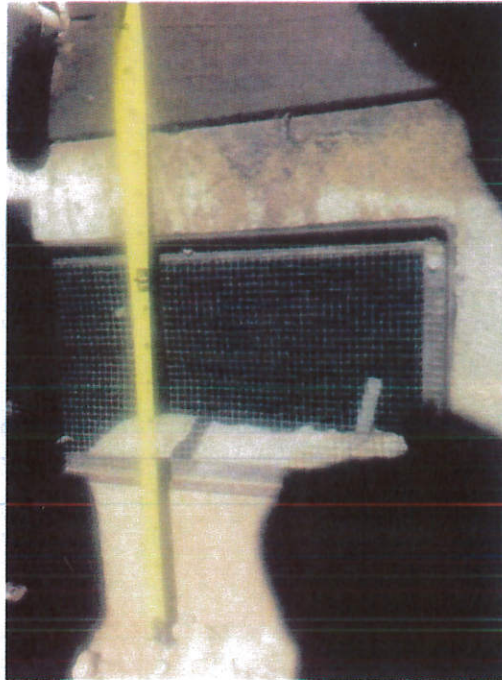

OF LOT 4 WINEGLASS ACRES

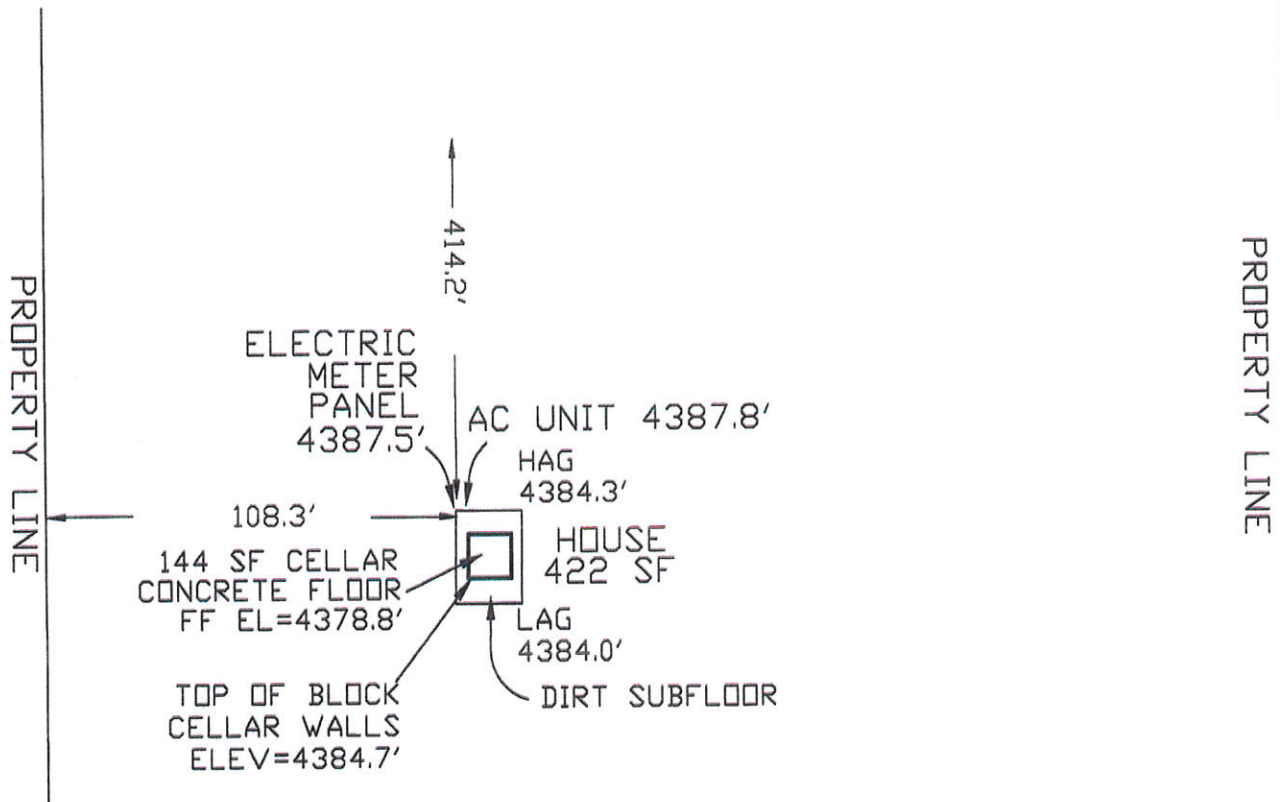
