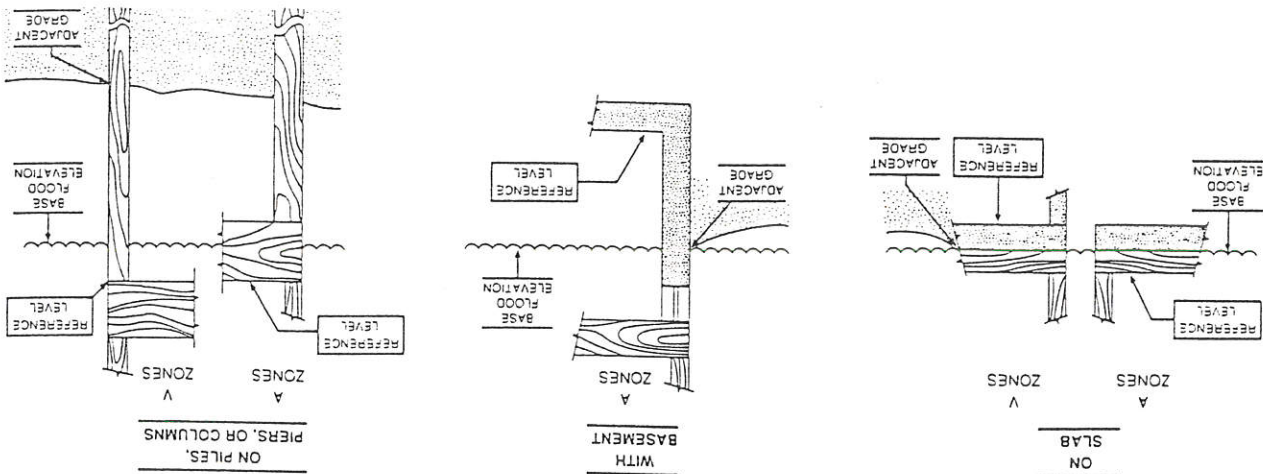

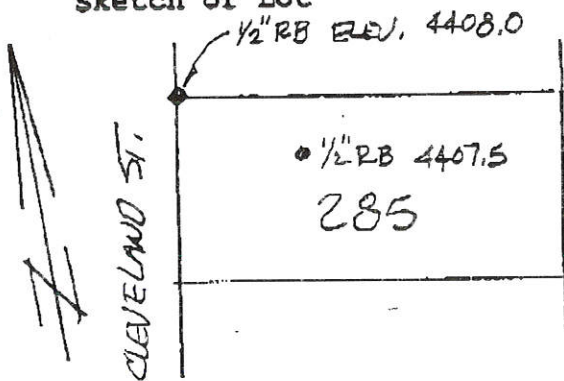

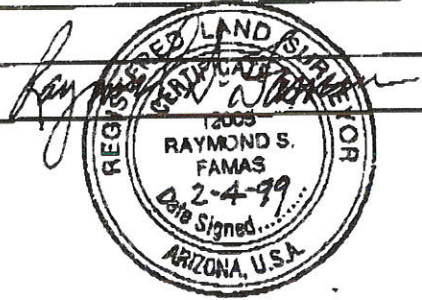
GROUND ELEVATION AT BUILDING SITE 4407.5
