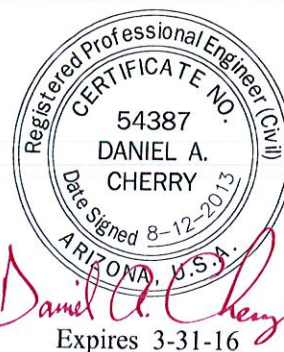

Comments For item C2.e: Lowest elevation of machinery is provided at lowest adjacent grade at the compactor location, which does not service the building, but is the lowest equipment on the site that may be subject to flood damage. All equipment and buildings at the Solid Waste Transfer Facility are elevated on compacted fill, placed with 2:1 side slopes or flatter, or retained with an engineered wall. On site floodwater velocities are minimal as flooding is due to backwater.
