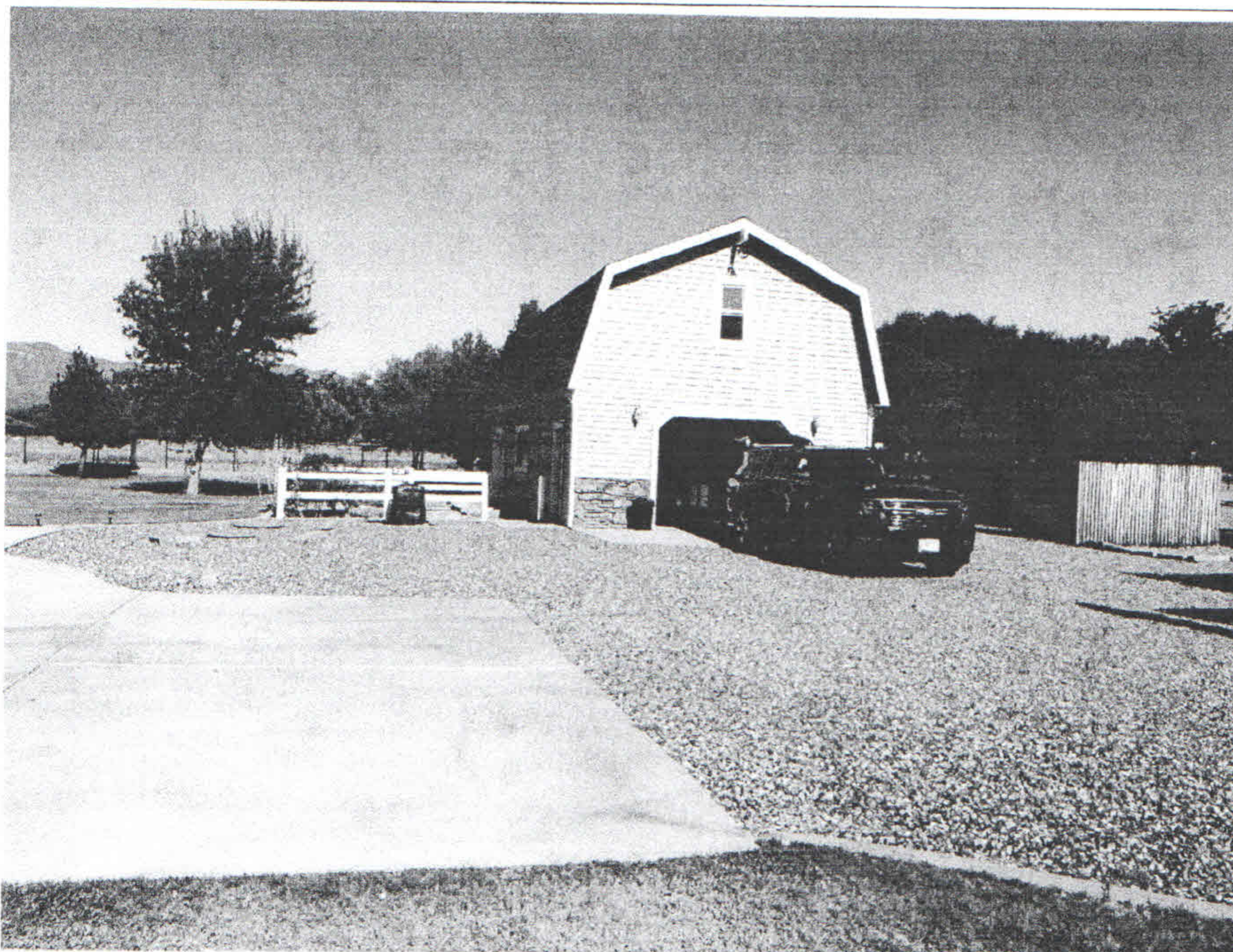

Photo One Caption EAST VIEW

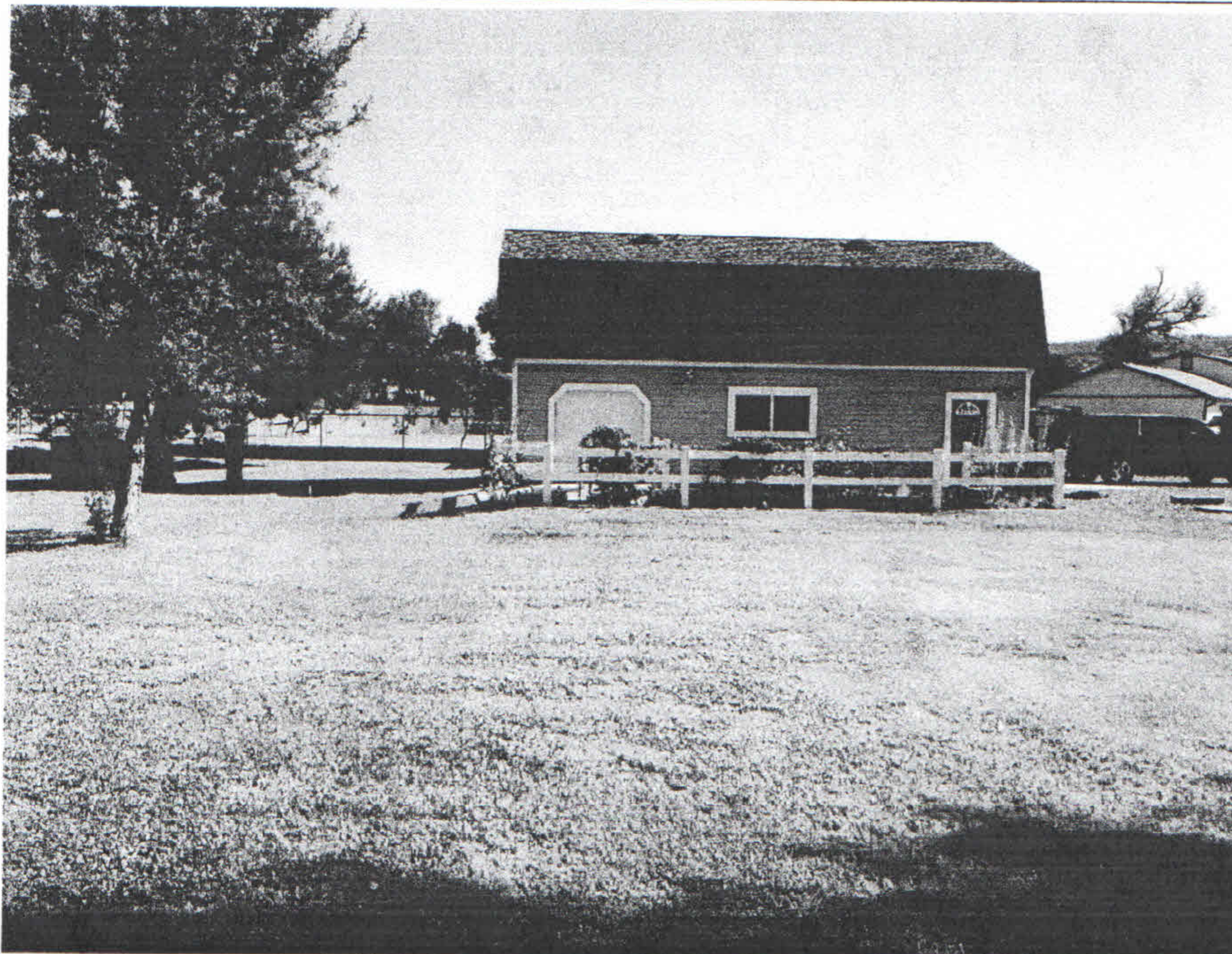

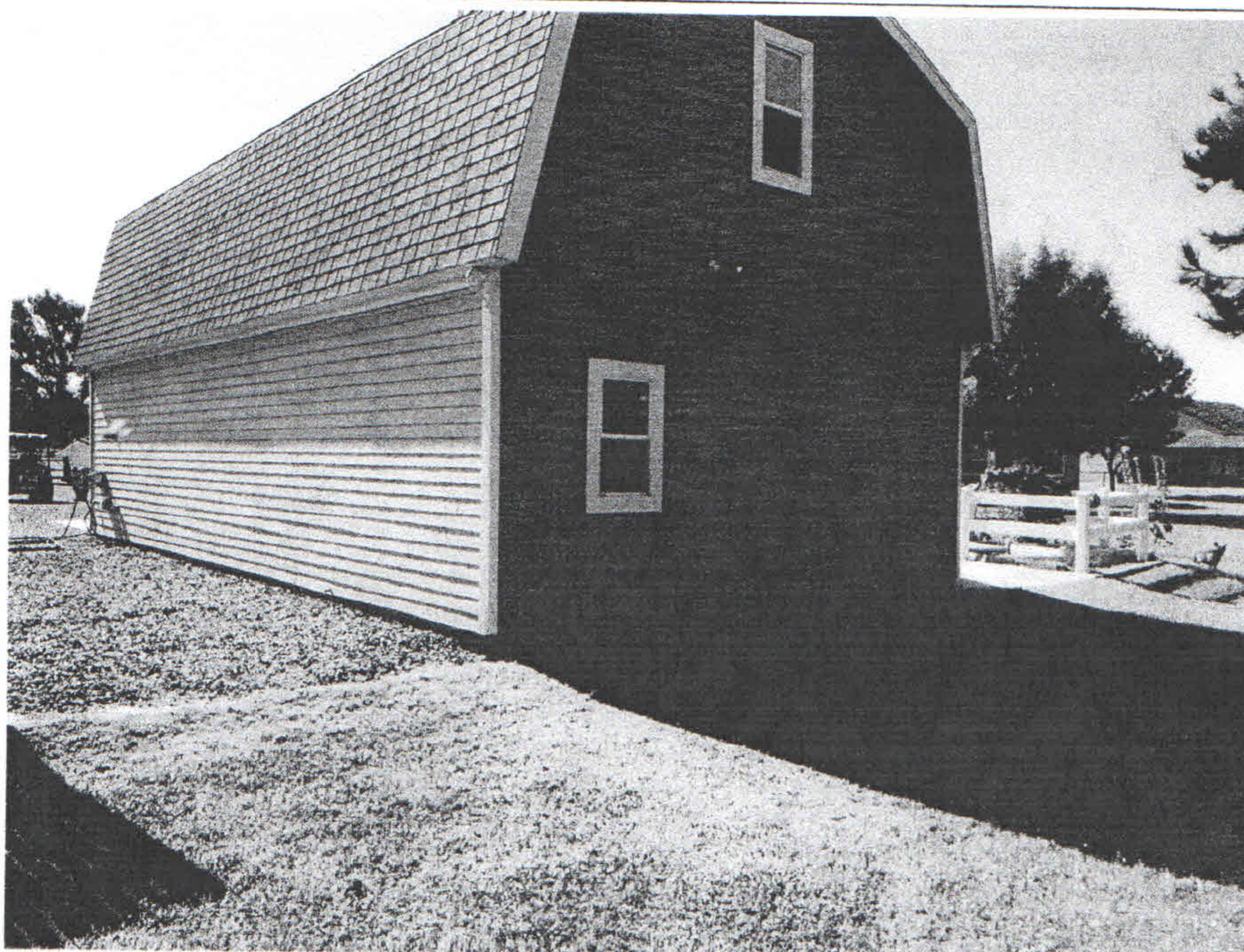

Photo One Caption SOUTHWEST VIEW

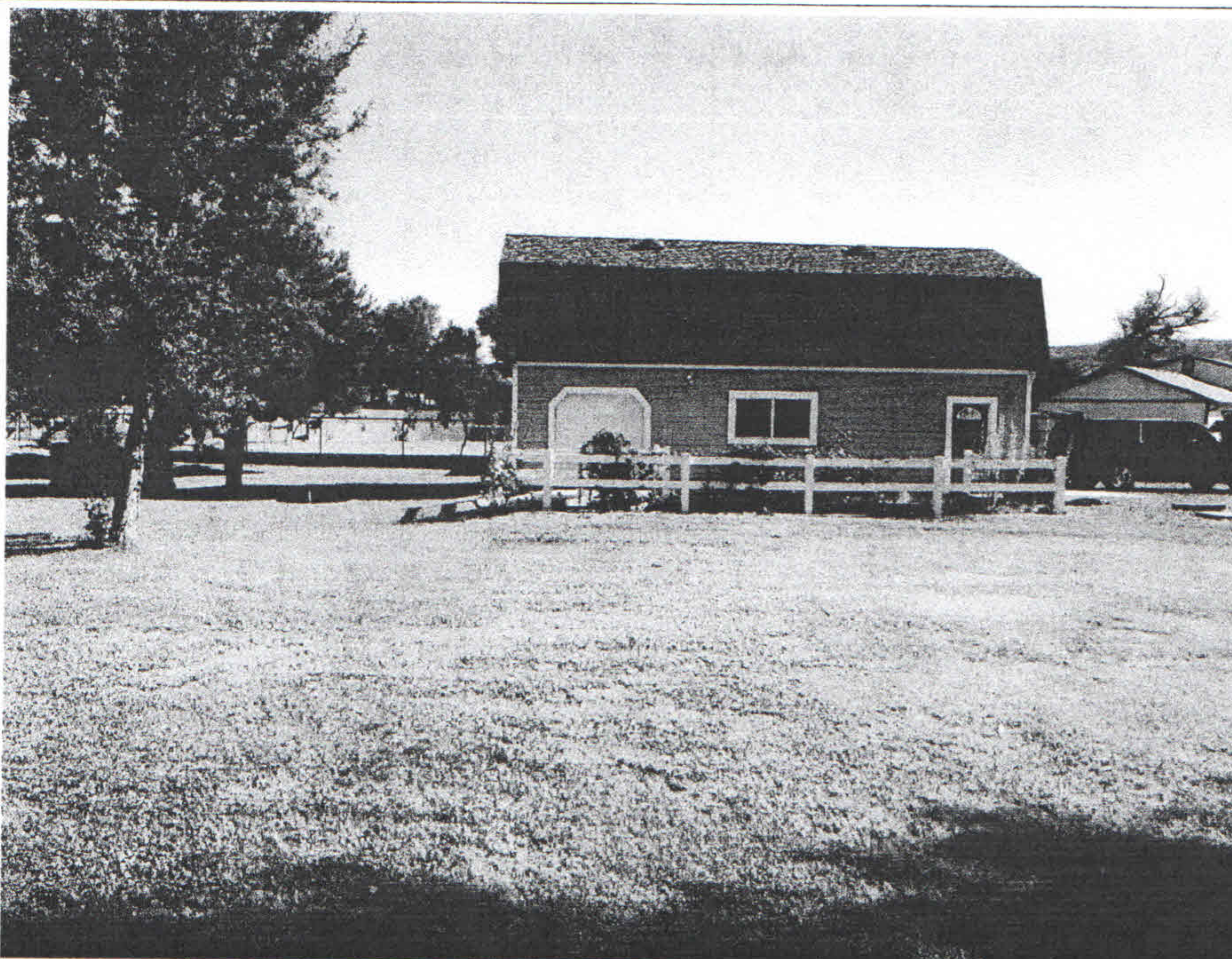
