Comments Equipment servicing the building is an electric power cabinet. The building is over 200 feet long with multiple wings located inside and outside of the designated flood zone. A lower basement was noted within the Zone X portion of the

property (see attached) with a lower floor elevation of 3394.36 feet. This building (portion with the basement) was originally constructed outside of the flood hazard area. The basement is only used as a storage area.

Additionally, Railroad WASH has been channelized around the building, and a small amount of parking lot drainage has been channelized under the building. (See attached picture)
