KWE Job No. 13-011EX. Latitude and Longitude derived from the Yavapai County Interactive Mapping Application. Section C has been completed at the request of the Yavapai County Flood Control District. Lowest elevation of equipment (C2.e) is the air conditioning pad located on the north (left side) of the building. The bottom of the electric meter panel is at elevation 3649.6. The bottom of the electric junction box below the meter panel is at elevation 3648.3. Lowest Adjacent Grade at structural support (C2.h) was measured at the lowest covered patio roof support column. The building is separated into two portions by a breezeway. The upper level of the breezeway is a viewing deck at elevation 3657.2. 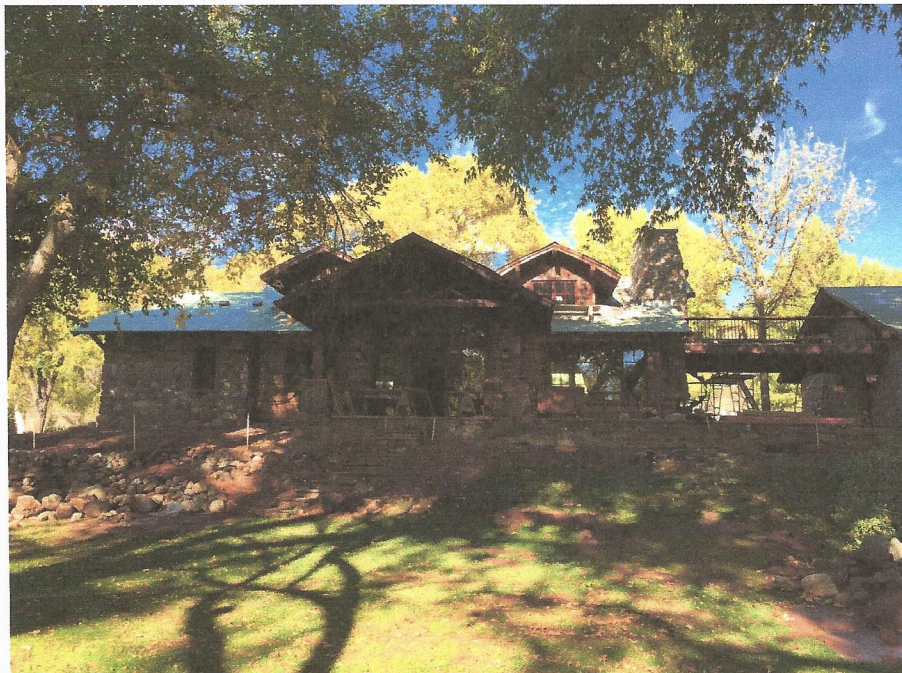

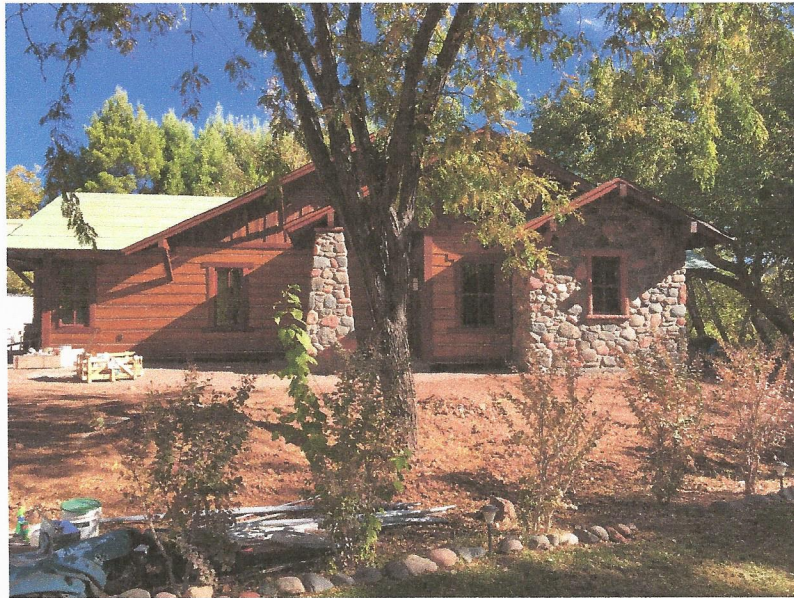

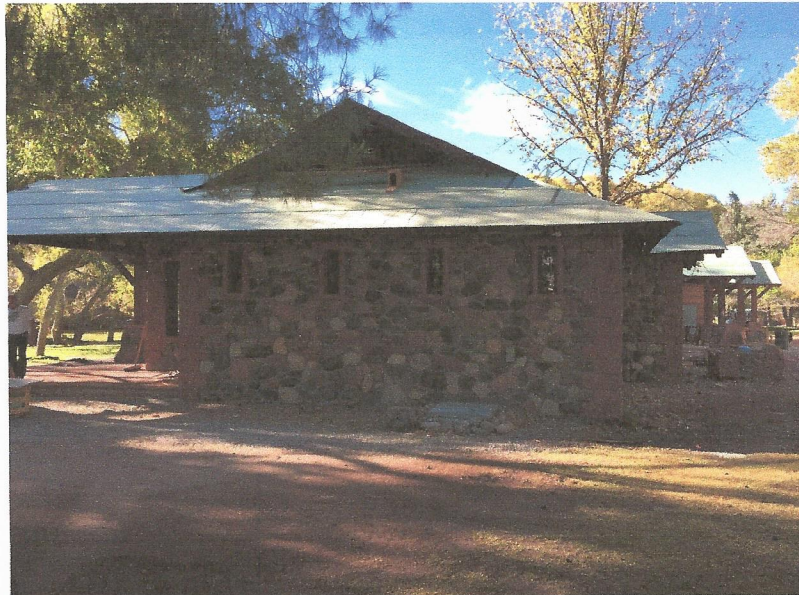
