Datum conversion in the area is NGVD 1929 + 2.60' = NAVD 1988. The converted MFFE on the final plat are 3930.60 for Lot 17 and 3929.60 for Lot 18 (NAVD 1988). The BFE in B9 was determined by the Yavapai County Flood Control District for Lot 18 (the determined BFE for Lot 17 is 3925.2).
