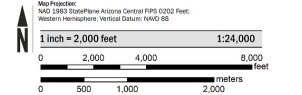

For community and coverage map uses refer to the Flood Insurance Study report for the jurisdiction.

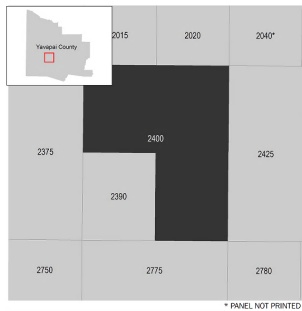
